Texas Government Code Section:

- 551.082 Considering discipline of a public school child, or complaint or charge against personnel.
- 551.0821 Confidentiality of Personally Identifiable Information about a Public School Student.
- 551.084 Excluding witnesses from a hearing.
- 551.086 Discussion or deliberation regarding commercial or financial information that the Board has received from a business prospect that the Board seeks to have locate, stay, or expand in or near the District and with which the Board is conducting economic development negotiations; or to deliberate the offer of a financial or other incentive to such a business prospect.

Texas Education Code:
