Open Issues

Old Business

- Finding a company to service AEDs annually on both campuses

New Business

The committee reviewed current SHAC membership and discussed future needs.

Upcoming SHAC activities for 2025–2026 were reviewed, including:

- Children’s Health Fair (September 2025)
- Community Flu Clinic (September 2025)
- Stop the Bleed training for grades 10–12
- Heart and circulatory system lessons for grades 2–5
- Mental health and stress management education for grades 6–12

The group also discussed possible new topics for SHAC activities, including vaping education, obesity/healthy eating education, social media safety (including cyberbullying), and sex trafficking education.
